

# Terms of Use

Welcome to MicroSourcing! This website (<a href="https://www.microsourcing.com/">https://www.microsourcing.com/</a>) ("Site") is operated by MicroSourcing. Throughout the site, the terms "we", "us", or "our" refer to MicroSourcing.
